ROBUST ECONOMY


- State GDP INR 5.68 Lakh Crore, 11% growth








CHHATTISGARH JAN VISHWAS ACT

163 Minor Offenses Decriminalized

Imprisonment and fines converted to penalty and compounding of offence introduced

- Non-maintenance of records/registers
- Non-filing of returns/information
- Obstructing an Officer
- Violations of Government orders
- Submission of false statements / information





POLICY FOCUSED ON SERVICE SECTOR

- Industry Status for Tourism Sector
- One of the few States to incentivize hospitals
- Customized package for Rs. 500+ crore investment or 1,000+ employment
- Overall limit capped at 150% of Fixed Capital Investment
- Higher incentives for MSMEs in Bastar and Sarguja (Group 3 blocks)





POLICY INCENTIVES

Large Service Sector Package

- 30% Capital Subsidy with employment multiplier from 1.1 to 1.5
- Net SGST reimbursement for 10 years (in lieu of FCI subsidy)
- Electricity duty exemption up to 7 years
- 100% stamp duty exemption
- 75% EPF reimbursement for 5 years
- Training subsidy one month's wage up to Rs. 15,000

- Hotels & Resorts
- Convention Center
- Health & Wellness Centre
- Eco-Tourism Centers
- Adventure/ Water/ Amusement Parks


